

AFTER 60 YEARS...

#### HAS AMERICA ABANDONED BROWN vs. THE BOARD OF EDUCATION?

Brown v. The Board of Education, is a settled case, it rejected the practice of dual education systems as being considered separate but equal. However, the same arguments, or justifications leading up to this monumental ruling over sixty years ago was again challenged by activist Supreme Court Judge Antonin Scalia.

While hearing oral arguments on the affirmative action case, Fisher v. University of Texas, Judge Scalia commented that Blacks performed better while attending less advanced, slower paced schools. He pointed out that the majority of the black scientists do not come from fast paced schools like the University of Texas, but from lesser schools where they are not being "pushed" into classes that are more challenging.

Judge Antonin Scalia was appointed to the Supreme Court in 1986, by President Reagan. Conservatives tout him as one of the greatest legal minds ever to hold that position. Many though, view Scalia's remarks as challenging the Supreme Courts ruling on separate but equal educational systems.

But was this great legal mind correct in his observation, do we in fact have a dual education system. That same question still is that "800 pound gorilla in the room", has the issues which lead to Brown v. the Board of Education, ever been satisfied?

After the unrest in Ferguson Missouri, several organizations, magazines and think tanks tackled the issues which were the precursor to the violence which came to a head following Michael Brown's death; health, criminal justice and education.

National Center for Education Statistics: The U.S. spends more on education than any other OECD countries. (Organization for Economic Cooperation and Development) In 2010 The U.S. spent 39 percent more per full-time student for elementary and secondary education than the average for other countries in the OECD. However more money spent does not "trickle down" evenly to create a completely unified and equal educational systems. It has been the goals set forth, by LEAP Forward Inc., to help bridge the gap which still exist in our separate and unequal educational system.

**Essence Magazine:** If the endowments of all 105 HBCUs were added up, they'd still amount to less than 10 percent of Harvard University's endowment, which at upward of \$30 billion is the wealthiest of any college in the world."

**LEAP Forward Inc.:** Throughout the year, writes grants, solicits donations from the community, donors and education friendly business to offest the financial costs of education. Businesses such as Walmart Prince Frederick, SMECO-Southern Maryland Electric Co., Best Buy Co. Inc., Applebee's-Solomon Island Rd. and Jack and Jill of America, have step to the forefront in helping disadvantaged students actually envision education and careers in the growing world of STEM opportunities.

**Child Trends:** A non-profit and non-partisan research center that tracks vital data about children reported that Black parents, most of whom are less educated than the white parents studied, do not expect their students to attain as much education as white parents expect. These lower expectations by the parents in turn, leads to lower expectations from the student, less-positive attitudes toward school and fewer out-of-school learning opportunities.

**LEAP Forward Inc.:** Has set up numerous post school activities both to fill any educational gap and also to instill that positive sense of net worth. LEAP Forward in addition to a computer lab, a homework and tutoring/math lab, has established a youth group of students who have demonstrated high academic prowess as well as community service. The CASH students are a self -ran group, and members of the National Society of Black Engineers, (NSBE, Jr.) . This talented group organizes educational forums, workshops, tours and exhibits. They also allocate time to "rap" about current affairs which affect their everyday lives...and yes, they even on rare occasion ask the old timers for

**US News:** In seventh and eighth grades, blacks make up 16 percent of students, however account for 10 percent of students taking Algebra 1 and 9 percent of students passing the course. Nearly one in five white students took Calculus in high school, while one in 15 black students took Calculus. Fewer black students have access to a full range of courses to adequately prepare them for STEM careers( Science, Technology, Engineering and Math).

**LEAP Forward Inc.:** Took on the Calvert County Board of Education and prevailed. The Calvert County school system has implemented a full PCI-Pre-College Initiative program, with an emphasis on STEM enrichment courses to better enable students within their jurisdiction to compete with the more prepared schools districts, for placement in those fast paced schools cited by Judge Antonin Scalia.

#### **Does Pre-K Really Matter?**

\*\*Did you know:

- Pre-K students achieve at higher levels in Math and Reading than their peers who never attended Pre-K
- Pre-K students repeat grades less often
- Pre-K students need special education at far lesser rates
- Pre-K students are more likely to attend college
- Pre-K students tend to earn more money over their lifetimes

In addition, research from the Montgomery County Public School system results indicate students who attended a full day Head Start Pre-K Program excel greater in both Math and Reading than those students enrolled in the Pre-K MCPS half-day courses.

#### PRESIDENT OBAMA AND EDUCATIONAL REFORM



Standardized testing falls under No Child Left Behind (NCLB), signed into law on January, 2001 by President George W. Bush. The law did not require any national standard of testing but each state in order to receive federal funding must administer annually standard tests to its students. No Child Left Behind (NCLB) requires all public schools receiving federal funding to administer a statewide standardized test annually to all students. Each stae may have a different name associated with the bill. Schools that receive federal funding through the Elemantary and Secondary Education Act of 1965 must make Adequate Yearly Progress (AYP) in test scores. For example, each year, fifth graders must do better on standardized tests than the previous year's fifth graders . NCLB has become the most important, and controversial method to gauge student's progress, the teacher's competence, the success/failure of a school as well as a states' commitment to education. With the stakes being so high, cheating must also be factored into this equation. A 2011 study by USA today, found, this system of rewards and punishments based upon a students test performance has lead to offenses ranging from helping students correct mistakes, making facial gestures during testing, failing to cover bulletin boards and even providing the students with actual test questions. Educators and administrators from Al\tlamta were recently given harsh prison sentences for their involvement in a NCLB cheating scanadl, where test scores were erased and changed, even though this practice has become widespread.

In a rare show of bi-partisanship, both houses in congress came together to past President Obama's educational reform legislation.. The proposal, known as the Every Student Succeeds Act (ESSA) cleared the Senate om December 10, 2015 by a 85-12 e margin but will not go into affect until July 1, 2017.

This is the biggest rewrite of our education laws in 25 years," Speaker Paul Ryan (R-Wis.) commented upon passage of the President's bill. "This shows what we can do when both parties work together."

The legislation reduces the federal government's control over the nation's public schools by transferring decision making power back to state and local governments in areas such as school performance and accountability. The bill also will allows local jurisdictions more influence over setting educational goals, school ratings and setting standards for struggling schools.

Two aspects of the legislation which will draw the attention of community based groups such as LEAP Foward Inc. is it's community based initiatives to:

- require districts to provide programs for homeless and neglected students
- community support for school success.
   LEAP Forward is way ahead of this mandate, in that our organization challenged and prevailed against the Calvert County Board of Education to establish a Pre-College Incentive program as part of its cirriculum and more recently the establishment of a Junior chapter of the National

Another aspect of ESSA organizations such as LEAP Forward will embrace is the establishment of a STEM Master Teacher Corp.

Commenting on the pasage of this monumental bipartisan legislation the President joked "We should do this more often."

Launching Educational Assistance Programs Forward (LEAP Forward), Inc. was conceived in 1998 and granted nonprofit status in 2001. The current board members consist largely of 1970s alumni from Calvert Senior High School in Calvert County, Prince Frederick, MD. (All of whom hold engineering and technical degrees). #### Presentations/Seminars/Events/Activities

#### **CONFERENCE ON BULLYING**



Students discuss one of the painful side affects on the paths and careers they have chosen to pursue, 'Bullying' It will be one of the many obstacles in which these students must overcome as a consequence of their pending success.

Bullying takes on many forms; verbal abuse. intimidation, physical abuse and even demanding money. Cyber bullying is also a form of bullying. Social networking tools like Facebook and Myspace have created new weapons the bully has in his/her arsenal. Jealousy, chosing the academics over 'fitting in.' also form the basis

LEAP Forward understands many students may be embarrassed to let their parents know they are being bullied. Our organization offers student ran rap sessions which allows the student to confront issues they feel are relevant.

- If the student that is being bullied is sick, stressed, not sleeping or is having other problems due to bullying, contact his/her counselor or other health professionals.
- If the bullying involves race, ethnicity, or disability and local help is not working contact the U.S. Department of Education's Office on Civil Rights.

## MARYLAND'S NEW GOVERNOR ON EDUCATION

Gov. Larry Hogan (R.Md.) ran and was elected as on a platform to support polices that would enhance Maryland's education system, "Education is our top priority... I believe that every child in Maryland deserves a world-class education."

The BOAST (Building Opportunities for All Students and Teachers) is a tuition tax credit bill, (also referred to as the Education Tax Credit) The bill has been opposed by the MSEA (Maryland State Education Association), the NAACP, League of Women Voters, Maryland PTA and the Maryland Association of Boards of Education.

BOAST is a voucher program that would shift public, taxpayer dollars into private schools. Although the bill has been introduced perennially In many forms since 2006, it has been rejected on each occasion by the Maryland General Assembly. However, newly elected Gov. Hogan has re-introduced the BOAST legislation again. Gov. Hogan's proposal would have given tax credits to corporations for contributions made to private schools .In addition, Gov. Hogan's budget would have slashed \$144 million from public schools next year-which would mean over \$3,600 less per classroom and more than \$100,000 less per school. The budget would also cut almost \$600 million over the next four years from Maryland Education.

The BOAST bill did not pass. the General Assembly did, however, pass legislation to keep 90% of Gov. Hogans proposed budget cut, \$132 million. The governor also has refused to act on the \$68.1 million in cuts to the Geographical Cost of Education Index, that the General Assembly is trying to restore.
